COURSE INTRODUCTION

KIMEP's College of Continuing Education jointly with the Central Asian Tax Research Center is preparing a series of executive courses leading to a certificate “International Tax Specialist”. The series will include 3 courses, gradually developing participant’s theoretical and practical knowledge related to international taxation, which could be taken either as stand-alone courses or as a series leading to the certificate:

- 1 **Introduction to International Taxation** – establishing the fundamentals and principles of international taxation and the practical aspects of tax treaty application
- 2 **International Tax Planning** – exploring international tax planning opportunities from Kazakhstani and international perspectives, use of holding companies, financing companies, etc.
- 3 **International Tax Compliance** – establishing understanding of compliance issues related to international taxation, issues of withholding taxation, and permanent establishment issues.

FOR WHO?

There is a lack of similar courses available in Kazakhstan and Central Asia. Experience shows that the business community has a significant demand of specialists carrying such qualifications and expertise. This program is an ideal training and career advancement opportunity for both domestic and foreign professional community, especially for: Financial Directors, Tax Managers, Chief Accountants, Investment Managers, Auditors, Tax Advisors, In-house Counsels, Lawyers and Investment Bankers.

ADIT

There is an option to link this series of courses to the first examination of internationally recognized – Advanced Diploma in International Taxation. The date for the first exam is June 2011. The examination takes place in Almaty. Candidates interested in this option will be able to take an additional course focused solely on exam preparation.
