FOREWORD BY KIMEP UNIVERSITY PRESIDENT

It is my pleasure to present the seventh edition of the KIMEP University Fact Book.

KIMEP University is a non-profit institution of higher education, in which all proceeds are reinvested into the academic mission. Its aim is to develop well-educated citizens and to improve the quality of life in Kazakhstan and Central Asia through teaching, scholarship, and community service. KIMEP University offers graduate and undergraduate degree programs in business, law, economics, finance, accounting, public administration, international relations and regional studies, media management, and public relations. All programs are taught in English, and all curricula match the highest international standards.

In January 2012, the Kazakhstan Institute of Management, Economics and Strategic Research (KIMEP) attained university status and became KIMEP University. This now allows for a broader range of programs, particularly at the graduate level.

KIMEP University bases all of its activities on its core values. These include integrity, freedom of academic thought,

transparency and meticulous care for the well-being of students, faculty, and staff. KIMEP University is also proud of the active role that students play in the decision-making process. Students have representation on all key committees, and the university's administration regularly consults with the KIMEP Student Association, which serves as the elected student government.

KIMEP University's world-class faculty has the largest concentration of Western-trained PhDs in the CIS. Currently, it has 88 PhDs educated at internationally-ranked universities such as Stanford, MIT, and Columbia in the United States of America, the University of Edinburgh and Manchester Business School in the United Kingdom, and Waterloo University in Canada. Our multicultural faculty plays a fundamental role not only in educating our students in their academic disciplines, from in preparing them for their role as global citizens.

The year 2012 saw two of the departments of KIMEP University's College of Social Sciences receive international accreditation. KIMEP University's two programs in Public Administration, the Bachelor of Social Sciences in Public Administration and the Master of Public Administration, were given unconditional, seven-year accreditation by the European Association for Public Administration Accreditation. The two programs in the Department of Journalism and Mass Communications, the Bachelor of Arts in International Journalism and the Master of Arts in International Journalism, received conditional accreditation from the American Communications Association, with the strong possibility of receiving full accreditation after one year. Finally, KIMEP University's market-leading Executive MBA program, taught in the Executive Education Center, is in the process of receiving full accreditation from the Foundation for International Business Administration Accreditation. These successes come the year after KIMEP University's Bang College of Business received Level 2 accreditation for its Bachelor's of Science in Business Administration and the MBA from the Asian Forum on Business Education. KIMEP University plans to attain full international accreditation for all of its academic programs by 2016.

Our international profile has continued to grow over the last year. KIMEP University now has partnerships with 96 international universities, of which 30 are ranked in the Top 200 by the Times Higher Education Supplement. This includes eight dual degree Master's programs with institutions in Europe, North America and the Republic of Korea.

Our student body comes from all social and economic backgrounds, and includes international students from more than fifty countries. At KIMEP University, they participate in an array of extra-curricular, community service, and student government activities. When they graduate, they have acquired the knowledge, critical thinking ability, and professional development necessary to become leaders of their societies.

The KIMEP Fact Book serves a key role in maintaining our total transparency to the public, giving all interested individuals the opportunity to have a complete picture of our operations. I hope that you enjoy learning more about KIMEP University. I am sure that you will find it to be an inspiring university worthy of serving the Republic of Kazakhstan for many generations to come.








